Craig Merrill started the discussion with stating that the Zoning/Environmental Health/ Solid Waste/ Flood Plain Manager/Drainage Tile work employee will be retiring in Palo Alto County.

The supervisors discussed tile repairs and who checks the county tile. The sanitarian in Emmet Co. is a part-time position. They discussed solid waste and the transfer station.

The supervisors discussed the odor from Project Liberty and Craig explained the process and testing they are doing to get the problem corrected.

Linus Solberg shared with Emmet County Supervisors information on watershed quality and nitrate removal. Linus suggested that Emmet Co. Supervisors should contact Jacobson-Westergard & Assoc. regarding watershed quality.

Craig Merrill discussed regional mental health and changes that have taken place in the Northwest Iowa Care Connections Region. Tim Schumacher spoke about the CSS Region.

Walter Davis-Oeth stated that he is working on tile crossing agreements under county roads and will present proposed agreements to both counties.

The Supervisors discussed union negotiations and the amount of pay increases given in both counties.

Craig Merrill closed the meeting with stating that sharing the county engineer has been a good thing.
