Pluth, Chair, called the meeting to order. All in attendance recited the Pledge of Allegiance. A motion was made by Glasnapp, seconded by Hash, to approve the minutes from last week's meeting with an addition, also approving them for publication, all ayes, motion carried.

During public forum, Tom Egeland, Custodian, came before the Board. Servpro was here yesterday to look at the Assessor's office for the smell issue. Servpro stated that what they believe they smell is stale air, not a musty smell. They stated that with not a lot of movement of the air, especially in the hallways, it could be creating this smell. They checked for moisture and did not find anything. They took some air samples from different areas (Assessor's, Juvenile Office, hallways and down in the boiler room). The air samples will be back next week. These samples will detect mold spores, if there are any. They did not see any issues outside, except for a small slice in the rubber roof. Hash stated maybe installing a permanent exhaust fan in the boiler room might help. The Board stated that they would wait until we get the air samples back.

Hash stated that he had recently attended a Central Iowa Juvenile Detention Center meeting last week in Eldora. Pluth went to a CSS meeting last week in New Hampton. He discussed some of the Counties are now getting paid for occupancy of Mental Health and County Social Services person in their counties. Kossuth and Winnebago Counties are still trying to leave the region, that would leave Emmet County as a non-contiguous county and steps may have to be taken to remain in the region if possible. Next month's meeting for CSS is going to be in Estherville at Iowa Lakes Electric on July 24 at 10:00. Anyone who would like to come is welcome, stated Pluth.

The Board rescinded the bill that was approved at last week's Board meeting for EPA #17 Main from Palo Alto County. This land lies in Palo Alto's drainage district #17, not joint drainage district EPA#17. A motion was made by Quastad, seconded by Glasnapp, to rescind the bill approval for \$240.00, which took place on June 25, 2019. All ayes, motion carried.

Lisa Rosburg, Drainage Clerk, presented to the Board the 2019 Drainage Assessments. The motion was made by Quastad, seconded by Hash, to approve the assessments listed as discussed by the Board, as Trustees of the Drainage Districts. All ayes, motion carried. The exception will be joint drainage district EK4. They will do more research on this joint drainage district and put it back on next week's Board meeting.

A motion was made by Glasnapp, seconded by Quastad to approve ½ of the FY2020 appropriations, with the exception of Secondary Roads and the Sheriff’s office. All ayes, motion carried.

Melanie Bauler, County Attorney, presented civil updates for the Board of Supervisors that have changed with the new legislative laws. Some of these new laws will take effect as of July 1. A few examples of some changes are as follows:

- As of July 1st all public intoxications are just simple misdemeanors;
- D.O.T. officers still remain Peace Officers;
- School permits now allow students to drive up to 50 miles one way, it was previously 25 miles;
- Sheriffs and Chiefs of Police now get a vote on the E911 Board.

Bauler also discussed some Board of Supervisors items that were discussed at the recent conference. She stated that in setting up the agenda for the Board, you as a Board can have discretion of whom you put on the Agenda. She also stated that the Attorney General advised you to be careful with the Open Forum (Emmet calls theirs’ Public Forum) on the Agenda. Pluth explained that we make no decisions or motions during that time and they usually use that time to share information on the meetings that they have recently attended with the other Board members. Bauler told the Board to be very careful with any discussions during this time. It was decided that they would leave the public forum item on the Agenda.

A motion was made by Hash, seconded by Glasnapp, to approve the Firework’s permits for:

The agenda item to set a Public Hearing date set for a new Construction Design Statement and Master Matrix for East Ingham Livestock Site was tabled due to not receiving the necessary paperwork from the DNR.

Quastad gave a short update on drainage district 70. He stated he had shared some information with Drainage Attorney, Rich Meyer.
