Chairman Pluth, called the meeting to order. The Board and all present recited the Pledge of Allegiance. Motion by Schumacher, second by Quastad, to approve the minutes from last week's meeting, also approving them for publication. All ayes, motion carried.

During public forum, Auditor Sathoff reported that Emmet County has received \$13,295.88 Federal FEMA COVID19 disaster funds. This is only the Federal portion.

The Board discussed the progress of the A26 paving project.

EMA Director Travis Sheridan reported that the City of Estherville and Avera Holy Family have approved their portion of the Christensen Building Generator hookup. Each entity has approved \$3,681.66. Emmet County's portion is \$3,681.66. This will be put on the Agenda next week for Board approval of L.O.S.S.T. funds.

Sheridan gave a brief COVID19 update regarding the outbreak in Armstrong. He also reported that no new cases have been reported in the last 2 days. He shared with the Board that a mask mandated would need to come from the Governor and that the surge site goes down this week.

Brad Haugen presented his Business Plan for purchasing the Country Greens Golf Course and the Hideaway at Country Greens Business Plan. Haugen is requesting \$50,000 from the Emmet County Revolving Loan Fund. Auditor Sathoff reported that the fund balance in the Revolving Loan Fund is \$76,728.26. Motion by Schumacher, second by Hash to approve a \$50,000 loan, paid semiannually at 2% interest pending contract approval. All ayes, motion carried.

Motion by Glasnapp, second by Hash, to approve the following joint drainage district claims for payment:
